## Complete Loan Package

This Job Aid walks you through how to upload a complete loan package in Pennymac's Portal both for Delegated and Non Delegated loans.

Loan packages have to be uploaded by submitting documentation:

- 1. Go to the Documents section of the loan.
- Upload documents using the Drag & Drop files option or Browse for files for selecting files saved in the computer.

- Once the uploading is completed, the uploaded document will appear as Completed in the screen:
  - 1. Click the Submit for review button.



- A submission overview page pops-up to submit the loan:
  - 1. Click Continue to confirm the loan submission.

After completing these steps, the loan is in the Complete Loan Package Received section in the pipeline.

## ATTENTION!

Now the loan is in the queue for PennyMac to review and all the editing options will be disabled.





Now, let's see how to upload multiple loans at once to complete the loan package process!



- Once in the Portal main page:
  - Click the Batch Document Upload tab. 1.
  - Click the Select a Document Upload 2.
  - View drop-down menu. 3.
  - Select the Upload Complete Loan Package option.

Steps 2 & 3 are necessary for clients registered for both Delegated and Non Delegated loans only.





- 1. Find the loan in the list and click on the arrow at the left of the loan line
- Click the Browse LOCAL DRIVE button 2. and select a file from the computer. The Drag and Drop option is also available.

TIP Multiple loans packages can be completed repeating these steps for different loans.

## After uploading the file:

Click the Submit button. 1

This step needs to be completed for each loan where documentation/packages have been uploaded.

With this last step the uploading of the loan package is completed!
