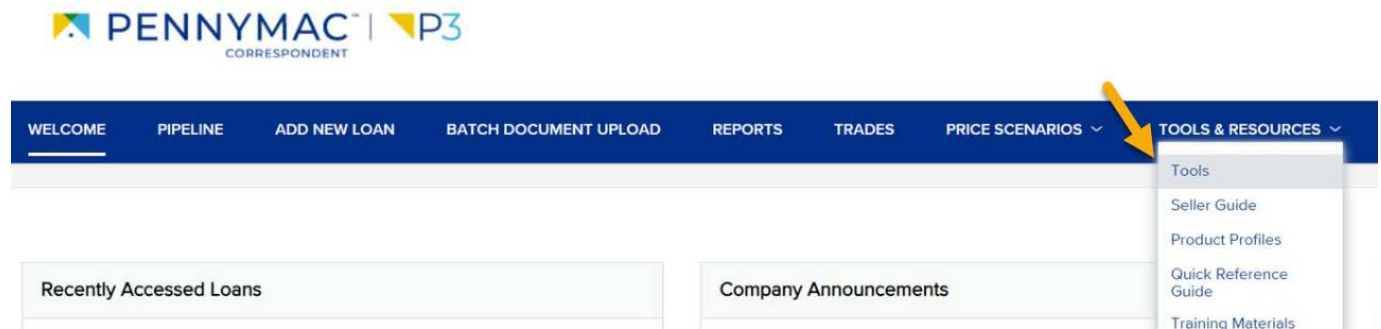


Anyone that is setup in P3 as an admin will have access to pull a scorecard at any time

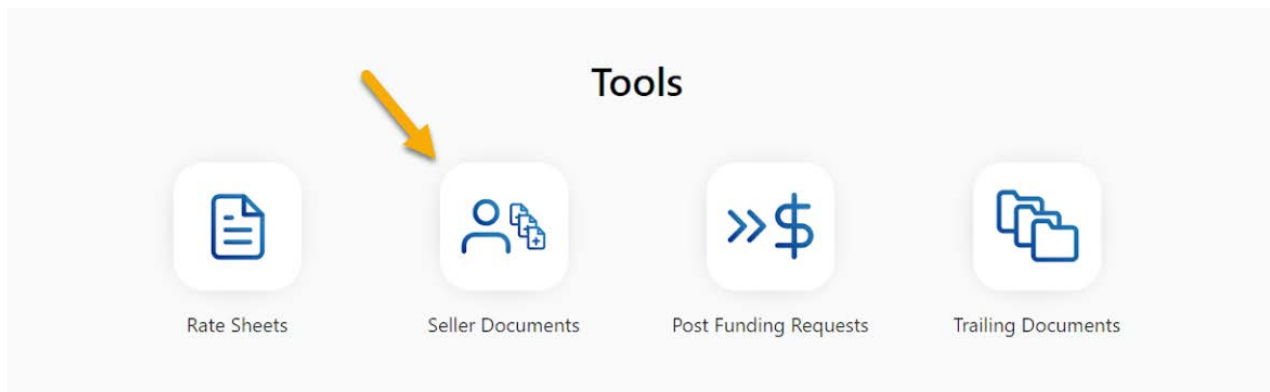
Step 1:
